Formal techniques of trade-theoretic general equilibrium analysis are used to analyze problems of economic growth and development, international trade and policy, income distribution and poverty, structural adjustment, and globalization in developing countries. Meets with Econ 877.
- AAE 473 *Economic Growth and Development in Southeast Asia*. The major nations of Southeast Asia are distinguished from the rest of the developing world by two main factors: very rapid economic growth and relative openness to trade. The course uses simple economic development models and SE Asian data to explore linkages between economic growth, trade, resources, policies, prices, and poverty alleviation.
